\*Applies to families who choose not to contribute at least \$720 annually to Saint Juliana Parish. Tuition is all-inclusive and there are no additional program or recurring fees.

**NEW FAMILY/STUDENT ADMISSION:** There is no fee to apply for admission. There is a one-time family fee of \$195 which includes enrollment for one student. Each additional incoming sibling incurs a one-time \$95 enrollment fee. Enrollment fees are non-refundable.

**ACCOUNT MANAGEMENT:** Tuition is charged on an annual basis and is payable to FACTS Tuition Management. Flexible payment plans and due-dates are available. The first installment is due in June and is non-refundable. A \$30 late charge is assessed if your payment is not received on a timely basis. Families are responsible for maintenance of their FACTS account profile. Tuition for mid-year enrollment or departure is calculated as a per diem of the annual rate.

**DELINQUENT TUITION:** Families are expected to budget and keep current with tuition payments. Collection activity will originate with FACTS, to include email, U.S. Mail and telephone contact.

**FINANCIAL ASSISTANCE:** Saint Juliana Parish has a limited amount of financial assistance available for participating families with children enrolled in grades K-8. Applications for 2017-2018 must be submitted online to FACTS Grant & Aid Assessment by May 5, 2017. **TRIP:** Our Tuition Reduction Incentive Program provides families with the means to directly reduce tuition through rebates on the purchase of gift certificates for groceries, gas, restaurant, department stores and more.
